



## Child Safeguarding Statement

The Peelo School of Dance is a dance school providing dance classes for pupils 2 ½ years – 18 years and adults.

We run our dance schools in

- 1) Unit B2 & B3 Celbridge M4 Business Park
- 2) Unit 6 Roscommon West Business Park
- 3) Presentation girls primary school, Maynooth
- 4) Kelleher's Dance Studio, Longford

Along with the owner Deirdre Brennan, there are four full time employees, Aimie Duignan, Caitriona Mulryan, Niamh Kirwan and Elaine McDonald.

We provide dance classes to our pupils. We ensure all pupils are cared for and respected while in our care of our dance school. It is the responsibility of our staff to make sure all pupils are safe and looked after while at class. We supervise the drop off and collection of all pupils from their parents/guardians.

The Designated Liaison Person (DLP) is Deirdre Brennan

We recognise that the protection and welfare of children at our dance school is of the most importance, regardless of all other considerations

We fully comply with the obligations of the Children's First act 2015 and other relevant legislation relating to the protection and welfare of children

We will fully co-operate with Tusla and an Garda Síochána in relations to child protection and welfare matters

We adopt safe practices to minimise the possibility of harm or accidents happening to children and protect employees and volunteers at our school from necessity to take unnecessary risks that may leave themselves open to accusations of abuse and neglect

We encourage parents and guardians to come to us with any concerns they may have and likewise we will go to parents and guardians with any concerns we have for their child if we think its safe to do so.

We fully respect confidentiality requirements in dealing with child protection matters

We have carried out an assessment of any potential for harm to a child while availing of our services. Below is a list of the areas of risk identified and the list of procedures for managing these risks.

<i>Risk Identified</i>	<i>Procedure for managing risk</i>
Child being left alone and not being collected from class	We make sure all pupils are collected by their parent/guardian/nominated adult, if they are not we will keep the child in our care until they are picked up by their parent/guardian or we will contact their parent/guardian
Children not feeling safe / happy at our classes	We make sure all pupils know at least two of our employees, we encourage them to come and tell us if they are not happy or if there is an issue with other pupils in their class that we should know of

Procedures Our Child Safeguarding Statement has been developed in line with requirements under the Children First Act 2015, the Children First: National Guidance, and Tusla's Child Safeguarding: A Guide for Policy, Procedure and Practice. In addition to the procedures listed in our risk assessment, the following procedures support our intention to safeguard children while they are availing of our service:

- ⇒ Procedure for the management of allegations of abuse or misconduct against workers/volunteers of a child availing of our service
- ⇒ Procedure for the safe recruitment and selection of workers and volunteers to work with children
- ⇒ Procedure for provision of and access to child safeguarding training and information, including the identification of the occurrence of harm
- ⇒ Procedure for the reporting of child protection or welfare concerns to Tusla
- ⇒ Procedure for maintaining a list of the persons (if any) in the relevant service who are mandated persons
- ⇒ Procedure for appointing a relevant person All procedures listed are available upon request.

We recognise that implementation is an ongoing process. Our service is committed to the implementation of this Child Safeguarding Statement and the procedures that support our intention to keep children safe from harm while availing of our service. This Child Safeguarding Statement will be reviewed on , or as soon as practicable after there has been a material change in any matter to which the statement refers.
